WELCOME

Jeffrey Swartz welcomed attendees and new members Jason Newson and Geoffrey Taylor from NJDOL DVOP in Jim Maggio's absence.

EVENT DISCUSSION

- Joe informed members he has contacted Ernest Dias, Managing Director from CAI to invite him to speak at the event. Joe is waiting to hear from Mr. Dias HR personnel to inform him what dates Mr. Dias would be available.
- Jeff told members he received information from Carol Dann to invite Jennifer Hoheisel, Coordinator of Autism Initiative from Camden County College to speak at the event. Barbara said Jennifer has a son who is autistic and she will contact her to see if she is available. Barbara added our focus is also on individuals on the spectrum demonstrating success working in the Information Technology (IT) field as well as Autism and invite employers to the event who have IT needs.
- Barbara informed members she has contacted the Center for Neurological and Neurodevelopmental Health (CNNH) to secure a clinician to speak on the panel. Barbara also has a Job Coach from the Ark of Philadelphia and Will Hoheisel to participate in the event. Jeffery Deitz added he will contact contractors he works with through the Schedule "A" event.
